About this report

PRI reporting is the largest global reporting project on responsible investment. It was developed with investors, for investors.

PRI signatories are required to report publicly on their responsible investment activities each year. In turn, they receive a number of outputs, including a public and private Transparency Report.

The public Transparency Reports, which are produced using signatories' reported information, provide accountability and support signatories to have internal discussions about their practices and to discuss these with their clients, beneficiaries, and other stakeholders.

This public Transparency Report is an export of the signatory's responses to the PRI Reporting Framework during the 2024 reporting period. It includes the signatory's responses to core indicators, as well as responses to plus indicators that the signatory has agreed to make public.

In response to signatory feedback, the PRI has not summarised signatories' responses – the information in this document is presented exactly as it was reported.

Section 1. Our commitment

- Why does your organisation engage in responsible investment?
- What is your organisation's overall approach to responsible investment, and what major responsible investment commitment(s) have you made?

True North is a leading private equity firm in India. Since 1999, our business model has focused on transforming mid-size, India-centric businesses into socially responsible enterprises. This transformation enables our partner companies to become world-class industry leaders. We have successfully launched six investment funds with a combined corpus of US\$ 3 Bn - including ~USD 500 Mn as co-investment.

Our investment philosophy is doing things 'The Right Way' wherein 'how' we do our business matters more than 'how much' business we do. We believe in adopting a principled, collaborative, and value-aligned approach with our partner companies to deliver boundless value for all stakeholders. Our approach to responsible investment is driven by our strategy to identify and invest in fast-growing, structurally attractive, socially responsible, Indian mid-market segment companies aligned with our core values.

To commit to our responsible investment philosophy, and in line with UNPRI commitments, we adopted a firmwide overarching Responsible Investment Policy ('RI Policy'). Our RI policy lays down overall expectations and commitments to adopting responsible investment principles in our operations. We have updated and revised our RI Policy in 2024. As a part of this overarching RI Policy, our ESG Policy and Implementation Manual ('ESG Policy') details the process of ESG integration in all our investments, including stewardship during the ownership period. We adopted our Climate Policy and Implementation Plan in 2021 which has since been updated and revised in 2024.

We also work very closely with the management of our partner companies, where we hold a position of influence, to support them to action a long-term strategic plan to achieve true potential in their business while keeping the long-term societal impact in consideration.

We believe that a diverse and inclusive culture enables workplace happiness and improves business performance. As part of our Responsible Investment Framework, we have now created DEI as an independent pillar to further strengthen our RI approach and our commitment towards DEI. The Firm has recently approved a Diversity Equity and Inclusion (DEI) Policy that shall be applicable to True North's own operations and its investing activities.

As the fourth pillar of our Responsible Investment Framework, we have developed a Sustainability Outcomes (SO) Framework aligned with the United Nations Sustainable Development Goals (the UN SDGs). This Framework improves our understanding of the positive and negative real-world impacts and outcomes related to our investments, thus giving us a three-dimensional view of the impacts that we are directly and indirectly a part of. We have categorized our goals and targets in three broad categories – Principle, Core socio-economic, and Sector-led outcomes.

We approach our investments to look beyond our ownership period. We aim to be a value adding partner for our investee companies. This involves working on both value creation opportunities and helping the partner companies comply with applicable ESG requirements and take necessary action against non-compliances, incidents (if any) and ultimately enhancing overall ESG performance. We organized multiple capacity building sessions for the Directors on the Boards of our partner companies to further strengthen our Stewardship efforts. It shall be our endeavour to enhance and align our stewardship process to include the role of Boards in providing strategic direction and monitoring ESG performance of our partner companies. We enhanced our stewardship efforts by joining investors' led initiatives like ESG Data Convergence Initiative (EDCI), Initiative Climat International (ICI), and participated in policy consultations.

Further, in our private debt investments, we have also developed a due diligence process to identify any potential ESG and climate change

Key elements of our responsible investment policy/ strategy are as follows:

- All Investments are covered under our responsible investment mandate
- ESG & Climate Change (CC) considerations included in the investment screening process in all investments in a differentiated manner
- In all our investments with active partnership, we collaborate to conduct/develop the following:
 - Materiality assessment
 - ESG Policy & Management System
 - Key ESG related Policies
 - Climate Risk resilience through appropriate policies, processes and action
 - Governance structure headed by CEO with periodic updates to the Board
 - Designated ESG Head
 - ESG performance aspects to be part of Internal Audit scope
 - Reporting on ESG information to True North on periodic basis
 - Annual declaration on compliance with applicable regulations and ongoing compliance with the True North's excluded activity list
 - Report on significant ESG related incidents in the company

Highlights of our Responsible investment performance during the reporting year .

Responsibility in investment

- Strengthened ESG & CC Governance by constituting an ESG and CC Governance Committee headed by the Managing Partner and with members including Investment Management and Operating partners, Private Credit, Chief Financial Officer/ Head of Firm Human resources. The Head of ESG and Climate Change acts as Convener and Secretary to the Committee.

Developed DEI Commitment and Policy and Sustainability Outcomes Framework as the third and fourth pillars of our Responsible Investment Framework.

- Enhanced our stewardship efforts both at the partner companies' level and with the investor community; organized multiple capacity building and awareness sessions for the Directors on the Boards of partner companies; and joining ESG Data Convergence Initiative and Initiative (EDCI), and Climat International (iCI). As a committed member of EDCI, we filed our first report in 2024.
- Identified ESG related policy gaps and developed policies like Human Rights Policy, Workplace Health, Safety and Well-being Policy, etc.
- Updated and revised our Responsible Investment Policy, and Climate Policy to align with UNPRI commitments.
- To further enhance our accountability and transparency, we commenced the practice of issuing fund-wise LP reports on ESG and Climate Performance.
- We performed screening of all Private Credit investments using our ESG Risk and Maturity Assessment Tool.

Resilience towards climate change

- We maintained Carbon Neutrality since inception in own operations by significantly reducing our carbon footprint and through carbon offsets.
- Enhanced collaboration with partner companies on the GHG estimation and reduction initiative with significant outcomes.
- We published our second TCFD report to disclose on our performance and climate related risks and opportunities on True North and our Partner companies

Reinforcing our partner companies

- First phase of ESG Assessment Framework implemented in partner companies of Fund V & VI and ESG roadmaps developed (for investments with influence)
- Awareness sessions conducted for partner companies on Climate, ESG regulations, etc.
- 67% of our partner companies are now estimating their GHG emissions, 83% monitoring their energy consumption, and 33% have renewable energy as an energy source.
- Continuing with the initiative of the earlier year, we conducted Climate Risk Assessment of our new investments.

Responsive to people

- Progressed on our commitment to diversity and inclusion - 27% women in own operations.
- >70% of partner companies recognized as "Great Place to Work" in India.

Section 3. Next steps

- What specific steps has your organisation outlined to advance your commitment to responsible investment in the next two years?

In the next two years, we shall focus on the following initiatives:

- **Materiality Assessment and a revamp of ESG strategy for the Firm:** We shall undertake a materiality assessment to identify key material topics for the Firm, after having carried out the assessment in 2020 that helped us in developing our policies and strategies at the time. The exercise shall also lay foundation for updation of our ESG strategy.
- **Integration of Technology:** Our aim is to leverage the full potential of technology for ESG integration in our investments. We plan to integrate ESG screening, due-diligence and post investment phase for a holistic approach in our digital tool – KERP. We propose to integrate data collection, monitoring and reporting on the tool to enable reporting on a more periodic basis. To enable our partner companies stay on the sustainability journey beyond our ownership period, we plan to develop a customisable ESG data reporting segment on the existing tool. This will allow for each partner company to create their own KPIs and metrics based on their materiality and track and report performance going forward. We shall develop a portfolio level dashboard depicting the overall performance of all our partner companies and comparisons of companies within each sector and across different themes for proper benchmarking and improvement.
- **Developing a Sustainability Outcomes Framework:** We shall implement the Sustainability Outcomes Framework based on the UN Sustainable Development Goals (SDGs) in the Firm and in our investments. The Framework aligns with our sectoral focus, investment strategies and existing ESG practices.
- **Developing a DEI Strategy for True North and our Partner Companies:** Continuing with our work from the past year, we shall implement the Diversity, Equity and inclusion Policy and Strategy for the Firm and for our investments. The strategy will also result in integration of DEI commitments in all new investments, and have been aligned with our Sustainability Outcomes Framework, and our overall commitments.
- **Mainstreaming Human Rights in the investment lifecycle:** Although elements of Human rights are incorporated in our Human Resources and ESG due diligence, we shall develop a plan to integrate Human rights in the investment lifecycle. This means that we will not only screen investments using human rights lens but also focus on value creation during our ownership phase and track progress on Human Rights performance of our investments on a regular basis.
- **GHG Reduction Plan for the portfolio:** We are working with the partner companies to help them understand their GHG footprint and prepare an inventory of emissions. Going forward, plan to work with each partner company on their GHG reduction plan.
- **Capacity building initiatives for firm and partner companies:** In order to further strengthen our efforts on creating awareness and capacity on ESG & Climate Change, we are putting together a structured program for both the employees at the Firm and for our partner companies. We also plan to develop online training module on ESG & Climate Change. Taking forward our initiative on creating capacity for the Directors on the Boards of our partner companies, we have now planned a bi-annual, in-person training for the Board members through experts/ consultants
- **Revision of policies:** We shall undertake revision of all our policies to remain updated with the current regulations, and also improve based on the learnings from our implementation, global peers, and UN PRI.
- **Strengthening ESG & Climate Governance:** In order to further strengthen our commitment, we now propose to conduct semi-annual review sessions on our ESG & Climate performance with the entire partnership.

Our private debt investments also have an exclusion list similar to equity investments. As the tenure of these investments is relatively shorter and we do not have the equity like rights to influence the decision of our investee companies in the post investment period, this limits our ability to conduct stewardship and/or proxy voting in Private Debt Investments. Therefore, our approach for ESG integration in Private Debt focuses on evaluating companies through extensive pre-investment diligence based on the specific nature of the transactions and the sectors that we are investing in. We have developed a proprietary 'ESG Private Credit Risk and Maturity Tool' to ensure meaningful ESG integration in Private Debt, and all deals have been screened through the Tool.

Our approach is to look beyond our ownership period in all our investments. We aim to be a value adding partner for our investee companies. This involves working on both value creation opportunities and helping the partner companies comply with applicable ESG requirements and take necessary action against non-compliances, incidents (if any) and ultimately enhancing overall ESG performance.

We are committed to perform our fiduciary duty towards our investors and other key stakeholders through a meaningful integration of ESG policies and processes in our investments. We believe that understanding ESG risks and managing them appropriately during ownership period is crucial for enhancing risk adjusted returns for our investors. Our two-stage diligence while evaluating an investment opportunity, meaningful stewardship during ownership, and working collaboratively to optimize on the value-creation opportunities helps us achieve this.

We follow a detailed process at the time of onboarding a partner company and collaborate with them to conduct their Materiality Assessment, develop policies and management systems, and ensure robust governance practices through establishing an ESG and Climate Change Governance Committee. We encourage them to monitor the ESG and Climate aspects and ensure periodic reporting to their Boards. This creates accountability within the companies and ensures institutionalization of their practices.

We further our accountability and transparency through issuing our ESG report, TCFD report, UNPRI filing, and a fund wise ESG and Climate Update to our LPs.

We do this by aiding them in identifying gaps, establishing measures and ensuring processes are in place. We have an ESG Assessment Framework in place to guide the process in a systematic manner. We also aid the partner companies (investees) to develop their implementation plan. While majority of our partner companies may not have a significant carbon footprint, their operations, supply chains and businesses are vulnerable to physical climate risks. We take meaningful steps to collaborate with each of our partner companies to enable an understanding of climate risks. Therefore, we carried out Climate Risk Assessment of our portfolio and are currently working with our partner companies to develop mitigation measures for the climate risks identified.
